

MISSAUKEE COUNTY PARK RULES

5-20

IT SHALL BE UNLAWFUL TO PERFORM ANY OF THE FOLLOWING ITEMS:

1. TO REMOVE, TAMPER WITH, DESTROY, OR DAMAGE COUNTY PROPERTY.
2. TO DESTROY, DAMAGE, OR DEFACE ANY TREE OR OTHER VEGETATION, INCLUDING NAILING OR GATHERING WOOD.
3. TO ALLOW ANY ANIMAL UNLEASHED IN THE PARK. **ALL PETS MUST BE ON AN 8 FT. OR SHORTER LEASH AND UNDER CONTROL.**
4. TO ALLOW CONTINUOUS **BARKING/NOISE** ANYTIME FROM ANY ANIMAL.
5. TO **NOT PICK-UP AND DISPOSE OF WASTE** ITEMS FROM ANY ANIMAL OR ANIMALS.
6. TO ALLOW ANY ANIMALS BEYOND THE CAMPING AREAS, ROADS OR UPPER BALL DIAMOND AREAS. **NO ANIMALS ARE ALLOWED ANYWHERE ELSE IN THE PARK!**
7. TO CAMP WITHOUT A WRITTEN PERMIT OR RECEIPT.
8. TO ADVERTISE ANY ITEM FOR SALE ON COUNTY PROPERTY WITHOUT CONSENT OF THE PARK MANAGER.
9. TO OPERATE ANY VEHICLE EXCEPT ON PARK ROADS. **NO ATV/UTV'S or GOLF CARTS ALLOWED**
10. TO OPERATE ANY VEHICLE AT A SPEED ABOVE THE POSTED AMOUNT OR IN VIOLATION OF THE POSTED SIGNS.
11. TO OPERATE ANY VEHICLE IN ANY UNSAFE MANNER DEEMED SO BY THE PARK MANAGER.
12. TO USE LOUD SPEAKERS OR AMPLIFYING DEVICES WITHOUT PERMISSION FROM THE PARK MANAGER.
13. TO MAKE EXCESSIVE NOISE AFTER 10 PM. FROM 10 PM TO 8 AM IS QUIET TIME AND THIS IS STRICTLY ENFORCED!
14. TO ALLOW VISITORS BETWEEN **10 PM AND 8 AM.**
15. TO HAVE CAMPFIRE ANYWHERE EXCEPT IN PROVIDED AREAS.
16. TO LEAVE GARBAGE ANYWHERE EXCEPT IN DESIGNATED CONTAINERS IN THE PARKS OR TO BURN OR LEAVE GARBAGE INSIDE FIRE PITS.
17. TO USE OR POSSESS ALCOHOLIC BEVERAGES ANYWHERE **EXCEPT** ON YOUR OWN CAMPSITE.
18. TO **SUBLET AN R.V. UNIT ON A SITE OR BOAT SLIP** IN THE PARK.
19. TO USE THE PARK FACILITIES AFTER 10 PM OR BEFORE 8 AM EXCEPT FOR THE RESTROOMS AND SHOWERS.
20. TO USE MORE THAN ONE PARK PROVIDED TABLE PER SITE.
21. TO CHANGE POSITION OF A CAMPING UNIT OR CHANGE SITE WITHOUT CONSENT OF THE PARK MANAGER.
22. TO HAVE MORE THAN **ONE UNIT** PER CAMPSITE EXCEPT FOR AN EXTRA SLEEPING TENT (ADDITIONAL FEE AND PRIOR APPROVAL REQUIRED).
23. TO DISOBEY LAWFUL ORDER OF THE PARK MANAGER.
24. THE MOORING OF ANY WATERCRAFT WITHIN **10 FT** OF THE BEACH/Shore
25. TO USE ANY PARK FACILITY THAT REQUIRES A FEE BEFORE PAYMENT OF SUCH FEE HAS BEEN MADE.
26. TO SWIM IN THE LAGOON AREA.
27. TO FAIL TO DISPLAY A VALID PARK VEHICLE PERMIT ON THE WINDSHIELD OF THAT VEHICLE BEFORE ENTERING THE PARK.
28. TO USE MORE THAN **ONE** LARGE APPLIANCE OUTSIDE (fridge/freezer/grill/washer/etc) AT ANYTIME ON CAMPSITES.
29. TO USE **ANY FIREWORKS** INSIDE THE CAMPGROUND OR PARK.
30. TO ERECT **ANY** BUILDING/SHED/STORAGE UNIT INSIDE THE PARK.

YOU MUST COMPLY WITH THE FOLLOWING:

1. FILL OUT THE REQUIRED REGISTRATION PAPERS WITH CORRECT INFORMATION INCLUDING CAMPER SIZE AND THE NUMBER IN YOUR PARTY. **NO** INCREASE IN PARTY SIZE WITHOUT CONSENT OF THE PARK MANAGER.
2. FOLLOW **ALL** PARK RULES AND REGULATIONS.
3. THE CHECK OUT TIME IS AT **1 PM SHARP.**
4. **Follow all CDC guidelines for virus prevention including: Hand Washing, Social Distancing, No Gatherings over 5 Persons, Etc..**

VIOLATION OF ANY OF THESE OR OTHER RULES SET FORTH IN THE MISSAUKEE COUNTY PARKS IS PUNISHABLE BY LAW WITH A FINE UP TO \$100.00 AND 90 DAYS IN JAIL AND/OR EVICTION WITH NO REFUNDS!!
