3. Business, mercantile, and storage buildings having HVAC equipment only, with one fire area and not more than 3,500 square feet.
4. Work completed by a governmental subdivision or state agency costing less than \$15,000.00.

**SECTION 7. INSTRUCTIONS FOR COMPLETING APPLICATION**

**GENERAL:** Mechanical work shall not be started until the application for permit has been filed with the Missaukee County Building Department. All installations shall be in conformance with the Mich. Mechanical Code. **NO WORK SHALL BE CONCEALED UNTIL IT HAS BEEN INSPECTED.** To schedule an inspection call - **231-839-7264** - providing as much **advance notice as necessary.** Please provide the **JOB LOCATION, PERMIT NUMBER and TYPE OF REQUESTED INSPECTION.**

**EXPIRATION OF PERMIT:** A permit is valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months after issuance of the permit or if the authorized work is suspended or abandoned for a period of six months after the time of commencing the work.

**A PERMIT WILL BE CLOSED WHEN NO INSPECTIONS ARE REQUESTED AND CONDUCTED WITHIN SIX MONTHS OF THE DATE OF ISSUANCE OR THE DATE OF A PREVIOUS INSPECTION. PAYMENT OF AN ADMINISTRATIVE FEE OF ONE-HALF OF THE ORIGINAL PERMIT FEE IS REQUIRED TO RENEW AN INVALID OR CLOSED PERMIT. NO INSPECTIONS WILL BE PERFORMED UNTIL THE ADMINISTRATIVE FEE IS PAID IN FULL.**
